#### **Apologies**

#### I. Minutes of the previous meeting

The minutes of the previous meeting were agreed.

# 2. Sharpe Pritchard LLP Briefing on the Board's Statutory Obligations

Ros Serrelli of Sharpe Pritchard briefed the Board about its statutory responsibilities as a new public body.

The Board **DISCUSSED** its responsibilities, including under the Parliamentary Buildings (Restoration and Renewal) Act 2019. Further clarification on fire safety responsibilities would be required, and the Board requested further details on their personal liabilities.

#### 3. Board Effectiveness Survey Results

The Board **DISCUSSED** its reactions to the survey and what it considered to be an effective Board for the Sponsor Body, and considered the suggested actions. This was a closed room session.

## 4. Board Regulations & Scheme of Authority

Sarah Johnson presented the draft Board Regulations & Scheme of Authority for the substantive Board. The regulations set out the proposed proceedings of the Board and its Committees and the responsibilities and authorities of the Sponsor Body's Officers.

The Board **DISCUSSED** the paper. The Board was content with the draft presented and looked forward to approving the final version in April.

## 5. Draft Parliamentary Relationship Agreement SS

Michael Torrance presented the draft Parliamentary Relationship Agreement (PRA) between Parliament and the substantive Sponsor Body. The Board was informed that the PRA would be revised at least once during the programme and that the draft presented reflected what was needed at the beginning of the substantive phase of work.

The Board **REVIEWED** the draft PRA. Questions were raised about areas of potential ambiguity in the text and suggestions for changes were made, particularly regarding roles in planning applications, external relationships, timely responses to requests made by the Sponsor Body, and obligations regarding fire safety and health and safety. The PRA would return to a future meeting, and the Board requested sight of the key annexes to which the draft referred.

The Board **TOOK NOTE** of the subsidiary PRA documents which were under development, and **TOOK NOTE** of the services the Programme might seek from Parliament and vice versa.

## 6. Managing Risk & Assurance through Transition SSB/20/014

Mike Brough and James Young presented a paper on managing risk and assurance through the transition to the substantive bodies. The paper gave the Board a comprehensive update on the progress of agreeing a structure with the Houses to handle risk once the Sponsor Body had become substantive. It was noted that risk and assurance would be managed in alignment with the PRA.
