Storage and art handling services are outside the scope of the DPS and both Parliament and the R&R Delivery Authority will procure these via alternative routes. 2	What kind of reporting is required post restoration and how much detail would need to be provided?	Reporting requirements will vary depending on the nature of the contract and the work undertaken. Details will be specified at point of tender and where appropriate templates or guidelines will be provided. The work to our objects is crucial, but it's also important that we understand and record that work appropriately to inform how we work with and use those objects going forward.	26/11/24
3	Will there be the opportunity for each group to be able to communicate collectively to enable us to all discuss ideas and disseminate information so we can all help one anotherPerhaps some kind of forum?	We are committed to fostering collaboration across the sector and recognise the CCDPS is an opportunity to increase professional skills and collegiate working. There will be certain cases where specific deliverables or methodologies will be outlined at the point of tender, whereas in some cases we will specify end state outcomes and be open to various delivery options.	26/11/24
7	Will the weighting be the same for each project? If so may we know the percentages?	No, the weightings will vary. The weighting of each tender award criterion, such as Technical/Quality aspects and Price, will be tailored to suit the nature of the individual project's service requirement. We have built into the DPS maximum flexibility which will enable us to allocate from 10% up to 90% weighting for Technical/Quality criteria. Generally, platforms and towers to enable access and health and safety equipment will be provided by the Customer (UK Parliament or the Delivery Authority). Specific details of what we will expect conservators to supply will be detailed in each invitation to tender. It will be very clear what you are expected to supply and what will be supplied by the Customer.	26/11/24
9	Will each conservation group be given a suppliers list of materials which have been agreed for use on objects to try and standardise products used? There are good and bad products out there on the market and perhaps its imperative that we all use the best materials available for such a collection.	There are likely to be stipulations around material/product use and again these are likely to vary depending on the nature of the work undertaken and the objects/environments involved. For example, in cases such as work to conserve upholstered furniture we may wish to stipulate a particular colour or quality of hide, to ensure consistency and standardisation across our objects. In other cases there may be health and safety considerations or particular object requirements that demand a certain material or approach is used. It is optional to fill it in: you don't need to if you don't want to, but we are asking for what your daily rate is. This is to help us build our own market understanding of what the range of rates is for different specialisms. We will use this for the purposes of planning and budgeting only. These rates are not fixed. They are provided only for information. Once you become a Member of the CCDPS, and are invited to a Call Off Competition, you will then be able to offer your latest rates, and these rates can be different to those submitted in Attachment 6.	26/11/24

Or can I respond on behalf of all parties?	If they will be your subcontractors and you are responding on behalf of all parties then they do not have to be on the CCDPS. Please note that the Customer will have to approve in writing the appointment of every subcontractor (as per clause 22.1 of the DPS Attachment 3 Call Off Contract) but this will take place once you are successful in being awarded a Call Off Contract. The Selection Questionnaire Question 1.3 requires you to provide some details of subcontractors in your SQ at a point of applying for a place on the CCDPS but only if you know their identity at this stage. In another more complex hypothetical scenario, if you were to apply as a group of companies or as a consortium, in such case all members of the group or the consortium would have to fill out SQ Parts 1 and 2. 		To add to that, the Professional Indemnity Insurance will also depend on the nature of the work being undertaken and the scope of that work. We appreciate that for small businesses it can be an extra overhead to carry insurance when you are not guaranteed that the work that you're doing needs that much cover, so we will be specific at the Call Off Competition stage to specify the level of cover required. Also, if Professional Indemnity Insurance cover was needed you wouldn't be required to enact this until you were notified that your tender was successful.	
16	Will work be allocated to just one conservation specialist, or multiple?	It really depends on each requirement and piece of work. There are various types of work that will be sourced through the DPS. For example, a single specialist might be needed for one piece of work, but potentially, for example, during the condition and move survey we might be looking at multiple conservators of the same specialism working at the same time.	26/11/24

We have deliberately left the description of this Service Category 1 to cover broad spectrum of monitoring. We appreciate that the word environmental can encompass a lot of different specific services. Within this specific Service Category we're talking about temperature, RH, light, vibration, particulate matter, but again it's a broad spectrum. We are looking to be able to bring in as many consultancies and companies which fit under that umbrella so that there are options for us to cover all of our potential requirements and to work with you all.	26/11/24

There is an option for conservation consultancy services included in descriptions of multiple Service Categories including Categories 1, 2, 4, 5. It would just depend on the works and our requirements as they emerge both in terms of the requirements of the Restoration & Renewal Delivery Authority and that of Parliament. However, the design based consultancy is outside of the scope of the CCDPS.	26/11/24
20	Let's say I am applying to a tender for a large project that requires myself to work with colleagues, do I apply as a sole trader or as a group?	If there is, for example, a tender that comes out saying we require, for example, five paintings conservators, we fully expect that there would be some companies that have potentially five paintings conservators within that company. I would assume that company would apply as one entity and then within the Call Off Competition they would then be able to specify how many conservators they were able to offer and specify that information. However, part of the thought process behind building this CCDPS system is also to include sole traders and give chance to sole traders who may not have large companies behind them. So we would encourage even if there are big projects that come out requiring multiple conservators of a specific specialism and you're a sole trader, we would encourage you to apply for that as well.
