## Freedom of Information Request - Reference: F25-002

Thank you for your email of 8 May 2024. We have considered your request under the Freedom of Information Act 2000 (the 'FOI Act').

## Request

You requested the following information:

I am writing to inquire whether there are any current or upcoming tenders related to Provision of Services for the Maintenance of ISO 9001, 14001 and ISO 45001 and ICT Audit Certification auditing services and Training services within your organization.

## Our Response

We hold the information you have requested.

The Delivery Authority does not have any current tenders relating to ISO standards.

The Delivery Authority issued a tender in March 2024 for the provision of an ISO External Audit and Certification from a UKAS accredited provider and a contract was awarded in July 2024. If you wish to exercise your right to an internal review then you should contact us within two months of the date of this letter. There is no statutory deadline for undertaking internal reviews and the timescale will depend upon the complexity of the matter.

We would normally endeavour to complete such reviews within 20 working days of acknowledgement,

and exceptionally within 40 working days. We will keep you informed of the progress of the review. If you wish to request a review you should contact foi@r-r.org.uk. If you are not content with the outcome of the internal review, then you may apply directly to the Information Commissioner for a decision.
